Executive Summary

History of LA 4/Starting Points

The LA 4 prekindergarten program began in 2001 with the passage of Senate Bill 776 and was designed to serve 4-year-old children who were not enrolled in publicly funded prekindergarten classes. The LA 4 program was modeled after the Starting Points prekindergarten program, which began in the 1992–93 school year. Both programs follow Louisiana Standards for Programs Serving Four-Year-Old Children and the Comprehensive Curriculum to insure the provision of high-quality services at no cost for those children eligible for free or reduced price lunch services (FRL). Children not qualifying based on income may pay tuition or may be locally funded. Over the past eight years, the following quantitative and qualitative parameters have emerged as the anchors of the Louisiana preschool effort:

Qualitative Parameters

- Certified early childhood teachers
- Highly qualified teacher assistants
- Vision, hearing, and dental screenings
- Developmentally appropriate materials and supplies
- Research-based and developmentally appropriate curricula
- Professional development opportunities that reflect needs identified through analyses of data
- Ongoing technical assistance and support
- Before- and after-school enrichment program
- Collaboration with physical health, mental health, and social service agencies
- Collaboration among early childhood stakeholders
- Support and adult education services for children and their families
- Strengths, Weaknesses, Opportunities, and Threats (SWOT) analysis to determine perceived strengths and needs

Quantitative Parameters

- Pretest and posttest measurement of student progress using the Developing Skills Checklist (DSC)
- Program evaluation and longitudinal research necessary to establish trends and predict outcomes
- Observation and evaluation using the Early Childhood Environmental Rating Scale—Revised (ECERS—R)
- Small classroom sizes of 20 children
- 10:1 child-to-adult ratio
- Full-day (six-hour) program
- At least 18 hours of targeted professional development each year
- Daily transportation

Who is Served by LA 4/Starting Points?

The targeted population for LA 4 are children identified as at risk for academic failure, based on qualification for FRL services. Ninety-three percent of LA 4 students in 2008–09 qualified for FRL services.

Nearly 13,157 children (86.5% of LA 4 students) received a vision screening, 12,025 children (79.0% of LA 4 students) received a hearing screening, and 3,441 children (22.6% of LA 4 students) received a dental screening.

* These numbers are estimates. Not all sites participating in LA 4 supplied screening data to the LDOE.

Improved Performance on the DSC

Each year, LA 4 students' progress over the school year is measured, in part, by comparing their pretest performance to their posttest performance on the DSC. In 2008–09, progress was measured in this way for 12,629 LA 4 students who completed both a pretest and posttest in Language, Print, and Math. LA 4 children showed significant improvement from pretest to posttest this year. The percentage of students scoring in the lowest quartile on the Developing Skills Checklist (DSC) decreased from 80% on the pretest in Language to 13% on the posttest. This improvement in scores moved students to the 50th national percentile for Language. In Print, student scores improved to the 59th percentile, and in Math, student scores improved to the 52nd percentile. All posttest scores were statistically significant and at or above the national average.

High-Quality Classrooms: Early Childhood Environmental Rating Scale—Revised (ECERS—R)

LA 4 classrooms routinely demonstrate the characteristics of high-quality early childhood education programs. Each year since its inception, the LA 4 program has been assessed using the Early Childhood Environmental Rating Scale—Revised (ECERS—R). The ECERS—R is one of the most widely used standardized measures of the quality of child care environments. The assessment examines seven areas reflective of a program's quality: space and furnishings, personal care routines, language reasoning, activities, interaction, program structure, and parents and staff. High ratings in these areas are associated with high-quality programs. Each year, the LA 4 program has received above-average ratings on this assessment and has compared quite favorably to similar programs in other states. This year's performance was no exception. A compilation of assessment scores for 111 randomly selected classrooms resulted in an overall score of 5.83 on a scale of 1 to 7. This 2008–09 ECERS—R score places the LA 4 program solidly in the "good to excellent" range, and scores have remained consistent since 2002.

What the Future Holds

For the past eight years, results from the evaluation of the LA 4 program have consistently demonstrated that high-quality early childhood education is positively impacting the academic success of Louisiana's at-risk children. In order to continue monitoring the short- and long-term progress of these children, the early childhood staff of the Louisiana Department of Education and the Picard Center for Child Development and Lifelong Learning at the University of Louisiana at Lafayette will continue to investigate the following research findings:

- Compare pretest and posttest scores of 4-year-old at-risk children who participate in the LA 4
 program to ensure that these students continue to show significant gains in the academic
 areas of Language, Print, and Math, year after year.
- Encourage schools to provide additional high-quality early educational opportunities to become "school ready."
- Identify LA 4 outlying districts (those districts that perform highest and lowest on the DSC on the posttest assessment).

- Determine factors that contribute to the success of the higher performing districts and ascertain the needs of the lower performing districts.
- Expand high-quality prekindergarten programs for targeted, unserved, at-risk 4-year-olds using the Picard Saturation Report.
- Continue efforts to improve and coordinate high-quality, diverse-delivery early childhood services for all children across the state.
- Increase student achievement on high-stakes assessments such as *i*LEAP, LEAP, and the Graduation Exit Exam (GEE) by increasing participation in LA 4.
- Reduce grade-retention rates by increasing participation in LA 4.
- Investigate the benefit of serving targeted, at-risk, 3-year-olds by identifying the essential predictors which would warrant a child's participation in two years of high-quality early childhood education.
- Identify LA 4's highest and lowest performing districts to ascertain the success indicators of the highest and the need indicators for the lowest.
- Track performance of LA 4 students as they enter 8th grade.
- Analyze LA 4 student high-stakes testing results for 7th-, 8th-, and 9th-grade students for their impact on student dropout rates.

LA 4 / Starting Points Prekindergarten Test Data 2008-09

In 2008–09, a pretest and posttest were given to each student enrolled in the LA 4 prekindergarten program for research and evaluation purposes. In each case, the test used was a portion of the Developing Skills Checklist (DSC), and this instrument was provided to all districts implementing the program. LA 4 students were assessed in the areas of Language, Print, and Math.

This section provides numerous ways of looking at the test results. All test information provided is for those students who had both pretest and posttest scores (n = 12,629). When looking at the data by school district, care should be taken with interpretation of results from samples that consist of fewer than 30 students.

First, graphs depict the percentage of children scoring in all four quartiles of the pretest and posttest. LA 4 students showed improvement after a full school year of instruction, and there was both a decrease in the percentage of students scoring in the lowest (first) quartile and an increase in the percentage of students scoring in the highest (fourth) quartile.

Second, a bar graph displays how student scores place in a national percentile rank (NPR) for pretest and posttest. The NPR is calculated by conversion of the mean score, using the national norms by grade (for districts with several years of participation, some years are not displayed due to limited space). Again, these numbers display the improvement of LA 4 students from pretest to posttest and show that, in most cases, Louisiana's 4-year-old students are scoring equal to or higher than the national average on the posttest in Language, Print, and Math. For six consecutive years, LA 4 children have scored in the 50th NPR in Language and the 59th NPR in Print on the DSC posttest. Trend analyses indicate a dosage effect when students exposed to a full year of prekindergarten instruction (2002–03, 2003–04, 2004–05, 2005–06, 2006–07, 2007–08 and 2008–09) show greater gains from pretest to posttest than those students who were exposed to only a half year of instruction (pilot year 2002). It should be noted that the DSC has no norm tables for children tested in the fall of prekindergarten; therefore, spring prekindergarten norms were used. This may underestimate the LA 4 students' actual performance relative to peers at that time. Earlier statistical analyses showed no difference in the significance of results based on use of the grade norms versus age norms.


Third, information is provided on the mean, median, range, and interquartile range for each district in Language, Print, and Math. This information is provided for the pretest and posttest and allows for observation of improvement.

Fourth, LA 4 and Starting Points (SP) programs are reported in aggregate. In the 2008–09 school year, 77 districts/charter schools participated in the LA 4 program.

Fifth, a t test procedure was run on the test results to identify significance in the scores. A t test determines the difference between two means. Three types of analyses were run on the test results: (1) comparison of the pretest mean number of correct responses (NCR) with the norming sample mean NCR, (2) comparison of the posttest mean NCR with the norming sample mean NCR, and (3) comparison of the mean NCR on the pretest with the mean NCR on the posttest for each child. These results are presented by district for Language, Print, and Math as " \blacksquare = significantly lower than norm," \blacksquare = significantly higher than norm" or " \approx = not significantly different from norm." Statistical significance is determined by a z-score of less than .05.

Test Results for LA 4 2008–09 Using National Norms

Test scores are reported for a total of 12,629 students, the number of students who had both pretest and posttest scores. Analyses of the test scores reveal statistically significant improvement statewide from pretest to posttest for students participating in the program.

National Percentile Rank

Another way to look at the student test scores is to convert the mean score to an NPR. The conversion of the student test scores to an NPR has remained consistent across years.




Figure 2. NPR for LA 4 students statewide in Language, Print, and Math.

National Percentile Rank for 2008–09 LA 4 Prekindergarten Students by Race and Ethnicity




Figure 3. Pretest and posttest scores in Language, Print, and Math, converted to an NPR, for 2008–09 LA 4/SP prekindergarten students by race and ethnicity.

The conversion of all LA 4/SP student test scores (by race and ethnicity) to an NPR for the 2008–09 school year is shown in the figure above. Children enrolled in the LA 4 program, regardless of race, demonstrated improvement on the DSC from pretest to posttest. It should be noted that the lower performance of Asian and Hispanic children in the area of language is potentially linked to the children learning English as a second language. These students' exposure to the English language during the course of one full school year proves to be beneficial as evidenced by their advancements from pretest to posttest.

Acadia Parish Schools

Acadia Parish Schools provided services to 117 at-risk, 4-year-old students who were enrolled in its LA 4 program in 2008–09. Test information is reported only for those students who had both a pretest and a posttest.




Figure 4. Percentage of LA 4 students in Acadia Parish Schools scoring in the respective quartiles on the DSC in 2008–09 (n = 117).





Figure 5. NPR for LA 4 students in Acadia Parish Schools in Language, Print, and Math.





Figure 7. NPR for LA 4 students in Algiers Charter Schools Association in Language, Print, and Math.





Figure 9. NPR for LA 4 students in the Ascension Parish School System in Language, Print, and Math.





Figure 11. NPR for LA 4 students in the Assumption Parish School District in Language, Print, and Math.





Figure 13. NPR for LA 4 students in the Avoyelles Parish School System in Language, Print, and Math.





Figure 15. NPR for LA 4 students in Bienville Parish Schools in Language, Print, and Math.





Figure 17. NPR for LA 4 students in the Bogalusa City School System in Language, Print, and Math.





Figure 19. NPR for LA 4 students in Bossier Parish Schools in Language, Print, and Math.




Figure 21. NPR for LA 4 students in the Caddo Public School District in Language, Print, and Math.




Figure 22. Percentage of LA 4 students in Calcasieu Parish Public Schools scoring in the respective quartiles on the DSC in 2008-09 (n = 993).





Figure 23. NPR for LA 4 students in Calcasieu Parish Public Schools in Language, Print, and Math.





Figure 25. NPR for LA 4 students in the Caldwell Parish School District in Language, Print, and Math. **Cameron Parish Schools**





Figure 27. NPR for LA 4 students in Cameron Parish Schools in Language, Print, and Math. **Central Community School System**





Figure 29. NPR for LA 4 students in the Central Community School System in Language, Print, and Math.





Figure 31. NPR for LA 4 students in the City of Baker School System in Language, Print, and Math.





Figure 33. NPR for Starting Points students in the Claiborne Parish Schools in Language, Print, and Math.





Figure 35. NPR for LA 4 students in the Concordia Parish Schools in Language, Print, and Math.





Figure 37. NPR for LA 4 students in the Concordia Parish School System in Language, Print, and Math. **DeSoto Parish Schools**





Figure 39. NPR for LA 4 students in DeSoto Parish Schools in Language, Print, and Math.




Figure 41. NPR for LA 4 students in Dr. King Charter School in Language, Print, and Math.




Figure 42. Percentage of LA 4 students in the Dryades YMCA James M. Singleton Charter School scoring in the respective quartiles on the DSC, 2008–09 (n = 32).




Figure 43. NPR for LA 4 students in the Dryades YMCA James M. Singleton Charter School in Language, Print, and Math.




Figure 44. Percentage of LA 4 students in the East Baton Rouge Parish School System scoring in the respective quartiles on the DSC in 2008–09 (n = 865).




Figure 45. NPR for LA 4 students in the East Baton Rouge Parish School System in Language, Print, and Math.






Figure 48. Percentage of LA 4 students in the East Feliciana Parish School District scoring in the respective quartiles on the DSC in 2008-09 (n = 37).




Figure 49. NPR for LA 4 students in the East Feliciana Parish School District in Language, Print, and Math. The Evangeline Parish School System




Figure 50. Percentage of LA 4 students in the Evangeline Parish School System scoring in the respective quartiles on the DSC in 2008-09 (n = 77).




Figure 51. NPR for LA 4 students in the Evangeline Parish School System in Language, Print, and Math. **Iberia Parish School System**






Figure 53. NPR for LA 4 students in the Iberia Parish School System in Language, Print, and Math. **Iberville Parish Public School System**






Figure 57. NPR for LA 4 students in the Jackson Parish School District in Language, Print, and Math.




Figure 58. Percentage of LA 4 students in Jefferson Davis Parish Schools scoring in the respective quartiles on the DSC in 2008-09 (n = 152).




Figure 59. NPR for LA 4 students in Jefferson Davis Parish Public Schools in Language, Print, and Math.




Figure 60. Percentage of LA 4 students in the Jefferson Parish Public School System scoring in the respective quartiles on the DSC in 2008-09 (n = 1,471).





Figure 61. NPR for LA 4 students in the Jefferson Parish Public School System in Language, Print, and Math.





Figure 63. NPR for LA 4 students in McDonogh #15 School for the Creative Arts in Language, Print, and Math.




Figure 65. NPR for LA 4 students in LaSalle Parish Schools in Language, Print, and Math.




Figure 66. Percentage of LA 4 students in the Lafayette Parish School System scoring in the respective quartiles on the DSC in 2008-09 (n = 670).





Figure 67. NPR for LA 4 students in the Lafayette Parish School System in Language, Print, and Math.





Figure 69. NPR for LA 4 students in the Lafayette Academy Charter School in Language, Print, and Math.





Figure 71. NPR for LA 4 students in Lafourche Parish Public Schools in Language, Print, and Math.





Figure 73. NPR for LA 4 students in Lincoln Parish Schools in Language, Print, and Math.





Figure 75. NPR for LA 4 students in Livingston Parish Public Schools in Language, Print, and Math. **Madison Parish Schools**





Figure 77. NPR for LA 4 students in Madison Parish Schools in Language, Print, and Math.





Figure 79. NPR for LA 4 students in McDonogh #42 Elementary Charter School in Language, Print, and Math.





Figure 81. NPR for LA 4 students in the Medard H. Nelson-UNO Charter School in Language, Print, and Math. **Monroe City Schools**





Figure 83. NPR for LA 4 students in Monroe City Schools in Language, Print, and Math. **Morehouse Parish Schools**





Figure 85. NPR for Starting Points students in Morehouse Parish Schools in Language, Print, and Math. Natchitoches Parish School System




Figure 87. NPR for LA 4 students in the Natchitoches Parish School System in Language, Print, and Math. New Orleans Public School System




Figure 88. Percentage of LA 4 students in the New Orleans Public School System scoring in the respective quartiles on the DSC in 2008-09 (n = 110).





Figure 89. NPR for LA 4 students in the New Orleans Public School System in Language, Print, and Math.





Figure 91. NPR for LA 4 students in the Ouachita Parish School System in Language, Print, and Math.





Figure 93. NPR for LA 4 students in the Plaquemines Parish School System in Language, Print, and Math.




Figure 95. NPR for LA 4 (previously Starting Points) students in the Pointe Coupee Parish Public School System in Language, Print, and Math.




Figure 96. Percentage of LA 4 students in the Rapides Parish School District scoring in the respective quartiles on the DSC in 2008-09 (n = 536).





Figure 97. NPR for LA 4 students in the Rapides Parish School District in Language, Print, and Math.





Figure 99. NPR for LA 4 students in the Recovery School District in Language, Print, and Math.





Figure 101. NPR for LA 4 students in the Red River Parish School District in Language, Print, and Math.




Figure 103. NPR for Starting Points students in the Richland Parish School System in Language, Print, and Math.




Figure 104. Percentage of LA students in the Sabine Parish School District scoring in the respective quartiles on the DSC in 2008-09 (n = 144).




Figure 105. NPR for LA 4 students in the Sabine Parish School District in Language, Print, and Math.




Figure 106. Percentage of LA students in St. Bernard Parish Public Schools scoring in the respective quartiles on the DSC in 2008-09 (n = 222).





Figure 107. NPR for LA 4 students in the St. Bernard Parish Public Schools in Language, Print, and Math.





Figure 109. NPR for LA 4 students (previously Starting Points) in the St. Helena Parish School System in Language, Print, and Math.





Figure 111. NPR for LA 4 students in the St. James Parish Schools in Language, Print, and Math.





Figure 113. NPR for LA 4 students in St. John the Baptist Parish Public Schools in Language, Print, and Math.





Figure 115. NPR for LA 4 students in the St. Landry Parish School District in Language, Print, and Math.





Figure 117. NPR for LA 4 students in the St. Martin Parish School District in Language, Print, and Math.





Figure 119. NPR for LA 4 students in the St. Mary Parish Schools in Language, Print, and Math.





Figure 121. NPR for LA 4 students in St. Tammany Parish Public Schools in Language, Print, and Math.









Figure 125. NPR for LA 4 students in the Tensas Parish School System in Language, Print, and Math.





Figure 127. NPR for LA 4 students in the Terrebonne Parish School District in Language, Print, and Math.





Figure 129. NPR for LA 4 students (previously Starting Points) in the Union Parish School District in Language, Print, and Math.





Figure 131. NPR for LA 4 students in Vermilion Parish Public Schools in Language, Print, and Math.




Figure 133. NPR for LA 4 students in the Vernon Parish School District in Language, Print, and Math.




Figure 134. Percentage of LA 4 students in the Washington Parish School System scoring in the respective quartiles on the DSC in 2008-09 (n = 173).





Figure 135. NPR for LA 4 students in the Washington Parish School System in Language, Print, and Math.





Figure 137. NPR for LA 4 students in the Webster Parish School District in Language, Print, and Math.





Figure 139. NPR for LA 4 students in West Baton Rouge Parish Schools in Language, Print, and Math.





Figure 141. NPR for LA 4 students in West Carroll Parish Schools in Language, Print, and Math.





Figure 143. NPR for LA 4 students in the Winn Parish School System in Language, Print, and Math.




Figure 145. NPR for LA 4 students in the Zachary Community School District in Language, Print, and Math.

The results of all test scores are reported using the students who had both pretest and posttest scores (n = 12,629).

Overall results for the pretest and posttest provide information on a child's acquisition of the following skills: 1) Language, 2) Print, and 3) Math, as measured by the Developing Skills Checklist (DSC). Each of these DSC scales is further divided into subscales. Tables 3 through 5 provide a symbol-coded summary of performance on these scales and subscales, statewide and by school district. The symbol ▲ indicates that LA 4 and Starting Points students scored significantly higher than the norming sample. The symbol ➡ indicates that LA 4 and Starting Points students' scores were comparable to the norming sample. The symbol ➡ indicates areas requiring additional emphasis or instruction, as LA 4 and Starting Points students scored significantly lower than the norming sample. Assignment of a table cell to one of these three categories is the result of conducting a t test to compare the mean proportion of correct responses for the students in that district to the mean proportion of correct responses for the norming sample.

Statistical tests were run for each of the subscales in the areas of Language, Print, and Math. There were seven subscales in Language, five subscales in Print, and eight subscales in Math.

Pretest

For the pretest, LA 4/Starting Points students statewide scored significantly lower than the national grade norms in all three areas of Language, Print, and Math. As such, these results are displayed as red squares (\blacksquare) in Tables 3–5. This indicates that student pretest scores were lower than the national grade norms and statistically significant at the p < .05 level; however, these results should be interpreted conservatively, as explained in Appendix A. As a hypothetical example, the z-score for "naming body parts" could be 5.66 at p < .0001. This indicates that the norming sample's mean percentage of correct responses of 0.75 for "naming body parts" (as found in Table 20 of the DSC Norms and Technical Bulletin) exceeded that of our students. As such, the skill requires additional emphasis.

In the Language portion on the pretest, students in 65 of the 71 listed school districts scored "significantly lower than the national norm" on at least one subscale. These results were seen most commonly on the subscales of "telling a 5-part story in sequence" and "demonstrating knowledge of opposites." These results are represented by the symbol ■ in Table 3.

In the Print portion on the pretest, students in 65 of the 71 school districts scored "significantly lower than the national norm" on at least one subscale. This was seen most commonly on the "identifying function of words and numerals" subscale. These results are represented by the symbol • in Table 4.

In the Math subscale on the pretest, students in 69 of the 71 school districts scored "significantly lower than the national norm" on at least one subscale. These results were seen most commonly on the subscales of "matching sets and numerals" and "identifying numerals." These results are represented by the symbol \blacksquare in Table 5.

Posttest

Student scores improved significantly from the pretest to the posttest as shown in the following tables. The posttest results demonstrate that almost all of the LA 4/Starting Points student scores met the national norm, and several exceeded it.

In the Language portion of the posttest, students in 30 of the 71 school districts scored significantly better than the national norms on at least one subscale. These results were seen most frequently on the "naming body parts" and "demonstrating knowledge of opposites" subscales. These results are represented by the symbol \triangle in Table 3.

In the Print portion of the posttest, students in 38 of the 71 school districts scored significantly better than the national grade norms on at least one subscale. This was seen most frequently on the "identifying components of written communication" subscale. These results are represented by the symbol \triangle in Table 4.

In the Math portion of the posttest, students in 21 of the 71 school districts scored significantly better than the national grade norms on at least one subscale. These results were seen most frequently on the "copying/extending patterns" and "naming shapes" subscales. These results are represented by the symbol \triangle in Table 5.




Figure 146. LA 4 prekindergarten students in 2008-09 by gender (n = 12,629).





Figure 147. LA 4 prekindergarten students in 2008-09 by race and ethnicity (n = 12,629).



Figure 149. LA 4 prekindergarten students in 2008-09 who have or have not received Part C* early intervention services (n =12,629).




Figure 150. LA 4 prekindergarten students in 2008-09 by primary spoken language (n =12,629).





Figure 151. LA 4 prekindergarten students in 2008-09 by annual household income (n = 12,629).

Figure 155. Highest educational level of the father or male guardian of 2008-09 LA 4 prekindergarten students (n = 12,629).




Figure 156. Nonparental care, by type, of 2008-09 LA 4 prekindergarten students (n = 12,629).

Appendix A. Limitations of 2008-09 LA 4 and Starting Points Data

Percentile rankings are commonly used to present the test results in a comprehensible manner. These rankings are useful in describing a score's position in relation to an array of scores. They indicate the percentage of children from a norm population who fall below a particular point. The DSC used in LA 4 and Starting Points provides two such rankings: (1) grade percentile, and (2) age percentile.

The grade percentile ranking compares children who are in the same grade at the same time of year, regardless of their age. The age percentile ranking compares children of the same age in years and months.

For the purposes of the evaluation of the 2008–09 LA 4 and Starting Points programs, the grade percentile ranking was used to compare LA 4 and Starting Points students with other students in the same grade at the same time of year. It should be noted that the DSC has no norm tables for children tested in the fall of prekindergarten; therefore, spring prekindergarten norms were used. The application of spring prekindergarten norms to the fall LA 4 and Starting Points students' test results establishes a baseline that may underestimate the students' actual performance relative to their peers at that time.
